


OREGON'S BOTTLE BILL - A GOOD IDEA!

- RICHARD CHAMBERS SOLD LOGGING EQUIPMENT AND LOVED THE OUTDOORS.
- HE HEARD THAT CANADA HAD A BOTTLE AND CAN DEPOSIT AND THOUGHT THAT WOULD WORK IN OREGON.
- HE HAD AN IDEA. IF EVERY BOTTLE AND CAN HAD A DEPOSIT THERE WOULD BE LESS MESS IN THE WOODS AND RIVERS OF OREGON.





OREGON'S BOTTLE BILL



- RICHARD CHAMBERS WANTED A
 DEPOSIT ON BOTTLES AND CANS TO
 GET PEOPLE TO TURN THEM IN FOR A
 REFUND AND NOT JUST LITTER.
- HE ASKED HIS STATE REPRESENTATIVE TO INTRODUCE A BILL.
- OREGON HOUSE BILL 1157 WAS INTRODUCED.

GOES TO COMMITTEE



- OREGON HOUSE BILL 1157 WAS ASSIGNED TO A COMMITTEE.
- THE COMMITTEE HELD A HEARING.
- THE PUBLIC WAS INVITED TO TESTIFY.
- AFTER HEARING THE PUBLIC'S OPINION, THE COMMITTEE VOTED.

WHO IS ON A COMMITTEE?

- LEGISLATORS ARE ON THE COMMITTEE.
- THE COMMITTEE IS A SMALL GROUP OF LEGISLATORS.
- A LEGISLATOR CAN BE ASSIGNED TO A COMMITTEE BASED ON THEIR INTEREST.



COMMITTEE HOLDS A HEARING

- PEOPLE HAD DIFFERENT OPINIONS ABOUT THE BILL AND SHARED THOSE OPINIONS.
- THE BILL PASSED THE COMMITTEE.
- AFTER THE COMMITTEE PASSED THE BILL IT WAS SENT TO THE HOUSE FLOOR FOR DEBATE AND A VOTE.
- THE HOUSE VOTED ON THE BILL AND IT FAILED.



MR. CHAMBERS WOULD NOT QUIT!



- HE GAINED MORE SUPPORT TO TRY AGAIN.
- A NEW BILL WAS WRITTEN.
- THE BILL WENT TO A NEW COMMITTEE.
- A HEARING WAS HELD ON THE NEW BILL.
- IT PASSED IN COMMITTEE.
- ON TO THE HOUSE FLOOR FOR DEBATE AND A VOTE.

OREGON HOUSE BILL 1036




- IF A BILL FAILS YOU CAN TRY AGAIN.
- THE NEW BILL HAD TO GO TO A NEW COMMITTEE AND A NEW HEARING WAS SCHEDULED.
- THE COMMITTEE PASSED THE BILL AND IT WENT TO THE HOUSE FOR DEBATE AND A VOTE.
- IT WORKED THE SECOND TIME. THE HOUSE PASSED THE BILL AND IT MOVED TO THE SENATE CHAMBER TO GO THROUGH THE SAME PROCESS.

SENATE VOTES

- THE SENATE LEGISLATORS DEBATED AND VOTED ON OREGON HOUSE BILL 1036. (THE BOTTLE BILL)
- THE BILL PASSED.
- WHERE TO NEXT? IS IT A LAW?



GOVERNOR SIGNS LAWS



- HOUSE BILL 1036 IS NOT A LAW UNTIL
 IT IS SIGNED BY THE GOVERNOR.
- WHEN GOVERNOR TOM MCCALL SIGNED THE BILL IT BECAME LAW.
- RETURNABLE CANS AND BOTTLES HAD A DEPOSIT OF 5 CENTS.
- THE DEPOSIT INCREASED TO 10 CENTS IN 2017.


THE GOVERNOR CAN ALSO:

- REJECT THE BILL WHICH IS CALLED A VETO.
- IF THE BILL IS VETOED IT CAN GO BACK TO THE LEGISLATURE FOR ANOTHER VOTE.
- A VETOED BILL CAN BECOME LAW IF 2/3RDS OF THE LEGISLATURE (HOUSE AND SENATE) VOTES FOR IT.

 THE GOVERNOR CAN ALSO CHOOSE NOT TO SIGN OR VETO A BILL WHICH WILL AUTOMATICALLY MAKE THE BILL A LAW.
